By signing this agreement, I further represent and warrant that I am the sole author and owner of the work and all rights in and to all portions of the aforementioned work; that the work is original; that it does not violate or infringe on any personal or property rights of others, whether common law or statutory; that it contains nothing libelous or otherwise contrary to law; and that I am authorized and empowered to enter into this agreement.
